

Mecklenburg Scout Reservation (Camp Grimes) Rifle and Shotgun Range Reservations

The following people are authorized to open the Rifle and Shotgun Ranges at Mecklenburg Scout Reservation (MSR) (Camp Grimes). You are required to have one of the MCC-RSOs present to serve as Range Safety Officer on each range reserved for the duration of the program in addition to an NRA Instructor for the appropriate discipline.

Range Reservation Process:

1. Submit a reservation through the mycampgrimes.org site, indicating the range(s) you wish to use. Reservations of ALL RANGES are **pending** until confirmed in writing/e-mail by the Camp Ranger.
2. Contact one of the MCC-approved Range Safety Officers in the list above to find one available to assist with your program. You need one for each range that you have reserved.
3. Once you have confirmed an MCC-RSO, have your NRA Instructor contact the MCC-RSO to review the proposed program and to submit their NRA Instructor credentials to the MCC-RSO. You need one Instructor per range.
4. After your Instructor has communicated and confirmed your shooting program to the MCC-RSO, then the MCC-RSO will notify the Camp Ranger that the range reservation can be approved. **NOTE: This must happen within two weeks of your request or your reservation for that range or ranges will be rejected (canceled).**
5. The Camp Ranger approves the reservation and your event/program may proceed.

OVER

Upon Arrival at MSR:

1. The MCC-RSO will present current credentials and obtain the SOP, range logbook, range keys, first aid kit, firearms, targets/clays and ammunition from the Ranger or the Camp Master.
2. Unit contact and NRA Instructor(s) will meet with the MCC-RSO at the range to review credentials and confirm the planned program. MCC-RSOs and NRA Instructors must have current credentials on their person while on the range.

Camp Policy:

1. Only the shooting sports equipment provided by the council is permitted in camp. No personal Rifles, Shotguns, Pistols, Ammunition, Bows, Arrows, BB/Pellet Guns or other items as described in Appendix 8 of the Shooting Sports Manual are permitted on any Mecklenburg County Council camp property.
2. Range Fees: Please refer to the Usage Fees document on www.mycampgrimes.org for details. A summary as of 2/14/2020 is listed below for convenience.

If you possess NRA Range Safety Officer credentials and would like to become an MCC-RSO, you can work with any current MCC-RSO to run two events (you act as RSO, the MCC-RSO supervises/trains you, neither of you can act as the Instructor for the event). The MCC-RSO then reports your accomplishment to the Mecklenburg County Council BSA Shooting Sports Committee Chair.
